Important instructions to all Manufacturers & Permittees of Electric Ceiling Type Fans

इलेक्ट्रिक सीलिंग प्रकार के पंखे के सभी निर्माताओं और परमिटधारियों के लिए महत्वपूर्ण निर्देश

1. All manufacturers/permittees of Ceiling fan under S&L program of BEE are hereby informed that the validity of existing star rating table for ceiling fan under mandatory phase has been extended by a period of 1 year i.e. till **31st December, 2025**. Accordingly, the revised sample label validity period is **17th January, 2024 to 31st December, 2025**.
2. The manufacturers willing to continue the registered models approved by BEE beyond 31st December, 2024 shall upload the previous approval letter with revised sample label on portal latest by 31st December, 2024.
3. For models already approved by BEE, the registered manufacturers/permittees have to submit the proforma enclosed with this advisory seeking willingness to continue the registered models with BEE beyond 31st December, 2024.
4. Kindly note, no continuation application for models would be accepted beyond 31st December, 2024 and models for which such requests are not received timely shall get deactivated automatically after 31st December, 2024. The portal to seek application for continuation of already approved models will be live w.e.f. **1st September, 2024 at 18:00 hrs.**

S.O. 3471(E).—In exercise of the powers conferred by clause (a) of section 14 of the Energy Conservation Act, 2001 (52 of 2001), the Central Government, in consultation with the Bureau of Energy Efficiency, hereby makes the following amendments in the notification of the Government of India, Ministry of Power, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), *vide* number S.O. 246(E), dated 17th January, 2024, namely:-

In the said notification, in paragraph A, in sub-paragraph II, in clause (3), in Tables, for the figures “2024”, wherever they occur, the figures “2025” shall be substituted.

(i) in sub - clause (a), after Table 3.1, the following Table shall be inserted, namely. -
