Important Instructions to all manufacturers/ permittees registered under S&L program for Solar Water Heater

1. All manufacturers/ permittees of Solar Water Heater under S&L program of BEE are hereby informed that the validity of existing star rating table for Solar Water Heater under Voluntary regime has been extended up to **31st December, 2025**.
2. Those manufacturers/ permittees of Solar Water Heater, who wish to continue use of approved BEE star label, shall submit sample label to BEE with revised validity period as **14th December, 2019 to 31st December, 2025**.
3. For models already approved by BEE, the manufacturers/ permittees have to submit the proforma enclosed with this Alert seeking willingness to continue the registered models with BEE beyond 31st December, 2024.
4. Kindly note, no continuation application for models would be accepted beyond 31st December, 2024 and models for which such requests are not received timely shall get deactivated automatically after 31st December, 2024. The portal to seek application for continuation of the already approved models has been made live **w.e.f. 20th November 2024 @15:00(IST)**.
