**Important instructions for all registered manufacturers and permittees under the S&L program for Air Compressor.**

1. All manufacturers/ permittees of Air Compressor under S&L program of BEE are hereby informed that the validity of existing star rating table for Air Compressor under voluntary phase has been extended till **31<sup>st</sup> December, 2025**. Accordingly, the revised sample label validity period is **11<sup>th</sup> January, 2021 to 31<sup>st</sup> December, 2025**.
2. Manufacturers/permittees who wish to continue the models approved by BEE beyond 31<sup>st</sup> December, 2024, shall upload the previous approval letter along with revised sample label on portal no later than **28<sup>th</sup> February, 2025**.
3. Accordingly, all approved models will remain active on the search and compare section of BEE's S&L portal till 28<sup>th</sup> February, 2025.
4. For models already approved by BEE, the manufacturers/ permittees have to submit the proforma enclosed with this alert seeking willingness to continue the registered models with BEE beyond 31<sup>st</sup> December, 2024.
5. Please note that, no continuation applications for model would be accepted beyond 28<sup>th</sup> February, 2025 and models for which such requests are not received timely shall get deactivate automatically after 28<sup>th</sup> February, 2025. The portal to seek application for continuation of already approved models will be live w.e.f **9<sup>th</sup> December, 2024, @ 11:00 AM**.
