**Important Instructions to all manufacturers/ permittees registered under S&L
program for Distribution Transformer**

1. All manufacturers/ permittees of Distribution Transformer registered under the S&L program of BEE are hereby informed that the existing star rating table for Distribution Transformer has been extended for a period of 1 Year with table validity period 1st July, 2017 to 31st December, 2024. The copy of the amendment notification published in the Gazette of India is enclosed herewith for reference.
2. Accordingly, all manufacturers of Distribution Transformer shall apply with revised sample label validity period as **1st July, 2017 to 31st December, 2024**. For models already approved by BEE, all the registered manufacturers willing to continue the registered models with BEE beyond 31st December, 2023 shall upload previous approval letter with revised sample label on portal latest by 31st January, 2024.
3. Kindly note, no continuation application for models would be accepted beyond 31st January, 2024 and models for which such requests are not received timely shall get deactivated automatically after 31st January, 2024.
4. Every manufacturer/permittee willing to continue with the existing model, already approved by BEE has to apply for "Change of Label to New Label" and get its model approved as per the revised label validity period. The continuation link will be available on the S&L portal w.e.f. 15th December, 2023.
5. The Distribution Transformer with revised label period shall not be delivered at retail outlets prior to 1st January, 2024.
6. Under the activity "Change of Label to New Label", once approved, the models with revised label period will directly appear on Search & Compare page of BEE star label website (<https://beestarlabel.com/SearchCompare>).

7. Following steps need to be followed for continuation of approved models:

Step 1: Login to www.beestarlabel.com portal to apply for "continuation of model" and click on link available against each model.

Step 2: Fill the Self Declaration form for the model that you wish to continue and upload the sample label (as per revised label validity period) and previous approval letter issued by BEE for that specific model.

Step 3: Complete the process by click on submit.

Note: The documents should be sealed and signed by the authorized signatory.


8. All manufacturers/permittees of Distribution Transformer who are willing to register new models of Distribution Transformer with BEE shall mention the label validity period in sample label as 1st July, 2017 to 31st December, 2024.

Note: The link would be active w.e.f. 15.12.2023 at 18:00 hrs.

S.O. 5247(E).—In exercise of the powers conferred by clause (a) of section 14 of the Energy Conservation Act, 2001 (52 of 2001), the Central Government, in consultation with the Bureau of Energy Efficiency, further to amend the notification of the Government of India, Ministry of Power, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), *vide* number S.O. 185(E), dated the 12th January, 2009, hereinafter referred to as said notification, namely:-

In the said notification, in sub-paragraph (2) of paragraph 2,

- (a) In Table 2, for the figures “2023” the figures “2024”, shall be substituted;
